Consignment Agreement for My Daughters' Closet

I _____, (hereafter referred to as "Consignor") do hereby attest that I agree to all of the following conditions of consigning with My Daughter's Closet.

My Daughter's Closet will receive all consignments during regular business hours unless other arrangements have been made and approved by boutique management.

We accept brand and designer name label items. Examples: Old Navy, Hollister, Abercrombie, Hurley, Bebe, Apple Bottom Jeans, 7, Dana Buchanan, Kenneth Cole, Prada, Louis Vuitton, Express, etc. ***Clothing must be in impeccable condition, smoke free and clean.*** Consider this; if you wouldn't buy it a second time around, why would someone else? We want to bring you and others clothing that will sell at a great price and quickly, to earn you the quickest return either in cash or store credit.

Pricing of consigned articles will be set by My Daughter's Closet. Pricing is determined by comparables, condition of clothing or accessories and original purchase price (usually between 20%-50% of original retail price). Consigned clothing will be marked down by 25% every 30 days (at MDC discretion), for a maximum of 90 days. Unsold items must be picked up within one week after the end of the 90 day period or they will, **WITHOUT FURTHER NOTICE**, become the property of My Daughter's Closet and can be sold or donated at our discretion.

The Consignor has a right to request an early pick-up before the end of the 90 day period, but must give a **two day notice before pick-up**. Consignor will be responsible for pulling all items to be picked up.

Consignor may renew the 90 day consignment agreement of the unsold items **once**. Maximum consignment time is 180 days total.

The final sales price of the articles will be split between My Daughter's Closet and the consignor, with the Consignor receiving 35% cash or 50% in-store credit of the final sale price.

Checks for items sold will be issued monthly after the **5th for the prior whole month**, if the balance due is \$10.00 or more. Smaller balances may be picked up or converted to store credit. Early pick-up (before the 5th of the next month) of consignment payment will be converted to store credit only. Consignment payments will be voided 180 days after agreement termination if consignment payment is not picked up or checks are returned in the mail.

It is the responsibility of the consignor to maintain all record of consigned merchandise and to contact My Daughter's Closet for all information on confirmed sales, pick-ups, and contract termination.

My Daughter's Closet does not assume responsibility for, or insure against theft, or loss of consigned property. My Daughter's Closet assumes no liability for damage to or destruction of any item consigned.
